

Support International Business (SIB)

Subsidy for

- Individual Trade Fair Participation
 - 50% of costs. Max. €2,500
- Collective activity
 - 50% of costs. Max. €1,500 trade mission, €2,500 trade fair
- Market entry
 - 50% of costs. Max. €2,500
- > Private Sector Development (PSD) and Business Development (BD) coaches
 - 50% of costs. Max. €1,000
- ➤ Knowledge and Skills
 - 50% of costs. Max. €2,500



Support International Business (SIB)

Conditions

- > SMEs in the Netherlands
 - Employees < 250
 - Annual revenue < €50 million
 - And/or annual balance < €43 million
- ➤ SME self-assessment questionnaire
 - > SME Questionnaire (europa.eu)






Support International Business (SIB)

Conditions

- ➤ Each SME only eligible once every 2 years for subsidy in the same target country
 - Except for trade fairs and trade missions
 - Max. €6,500 subsidy per SME per calendar year



DHI subsidies

- 1. DHI Demonstration Project
- 2. DHI Feasibility Studies
- 3. DHI Investment Preparation Studies



1. DHI Demonstration Project

- > Subsidy for a demonstration project
 - Max. €200,000, 50% of the costs

Demonstrate that technology, capital goods or services work, are effective and cost-effective in the local context






2. DHI Feasibility Studies

- Subsidy for a feasibility study
 - Max. €100,000, 50% of the costs

Demonstrate the technical and financial feasibility of Dutch products/services to potential foreign customers





3. DHI Investment Preparation Studies

- Subsidy for a investment preparation study
 - Max. €100,000, 50% of the costs

Enable investment or financing decision and project





Partners for International Business (PIB)

Cluster of companies and knowledge institutions (at least 5)

- > Incoming missions
- Seminars, participation in missions, company visits, matchmaking
- > Developing promotional materials
 - Coordination

Netherlands Enterprise Agency (RVO) and mission

- Activity funding, e.g.
 - Missions
 - Liaison
 - Holland Branding
 - Knowledge transfer
- Seminars, conference and fairs
- ➤ Max. €350,000, 2-3 years

PIB - NLHortiRoad2theGulf

Support the development of Dutch Agritech in horticulture in the UAE, Saudi Arabia and Qatar

- > A 3-year program
- ➤ Jointly offers solutions to investors and governments
- > 20+ participating companies
- ➤ Greenhouse, water solutions, lighting, microbial solutions, crop health expertise, hydroponics, warehousing operations design



Trade - and Economic Missions


- Meet potential business partners

- ➤ In cooperation with network of embassies, consulates and Netherlands Business Support Offices (NBSOs)
- Agents, distributors, production partners or franchisees






Insurance of commercial and political risks of export transactions and financing



Insurance and financing for export of capital goods by Dutch companies with:


- ➤ A credit period of >12 months **OR**
- > A risk horizon of >24 months **OR**
- Maximum compensation exceeds € 5 million





Benefits


- Better payment conditions for buyer and exporter
- Advance financing for exporter
- Longer repayment terms for the buyer
- ➤ Lower capital requirement financer, financing costs and interest for the buyer





Conditions insurance export credit and financing

- ➤ Contract is at least €100,000. No max. amount
- > Export of capital goods
- Max. 85% financing, 15% is down payment by buyer.
- At least 20% Dutch content in the transaction
 (e.g. production, overhead, revenue)
- Requester is based in the Netherlands





Conditions insurance export credit and financing

- > Percentage covered is 98% for political risk and 95% for debtors' risk
- For projects where the repayment is contingent on the revenue earned from the project, this could be lower (between 70 and 90%)
- > Also offers working capital coverage, insuring the exporters native bank
- Applications are judged by repayment capabilities, CSR-rating and a compliance check

> Financial product development

- Max. €5-50 million, 50% of the costs
- Total financing needs (incl. other funders):
 > €10 million
- Always at least 1 professional, private coinvestor
- The total financing cannot succeed without InvestNL participation



> Market development


- Market research
